# Pre-Construction Wall Mount Back Box: BB-V15

# **Description**


The BB-V15 back box provides a UL®-listed recess-mount steel enclosure for the V15-WALL V-Panel 15" Wall Mount Touchpanel display. It is also compatible with the WMKC-V15 V-Panel Wall Mount Conversion Kit. Designed for pre-construction applications, the BB-V15 permits fastening to the studs of a framed wall prior to installation of drywall. An assortment of knockouts is provided to accommodate conduit fittings, and a blank cover plate is included to provide a temporary cover of the opening during construction.

**NOTE:** If mounting into a material other than drywall (e.g., wood lectern, concrete, or rock) use the cutout template, available in the post-construction kit WMKM-V15 or WMKT-V15.

**NOTE:** For concrete and rock mounting material, allow for proper ventilation before mounting the touchpanel.

The mounted view of the BB-V15 is shown below.


BB-V15 Mounted View (Optional Cover Plate Attached)




**NOTE:** Allow an air gap of at least 12 inches (305 mm) in the wall cavity above and below the touchpanel for heat dissipation.

The dimensions of the BB-V15 are shown below and on the next page.


#### Overall Dimensions (Front View, 1 of 2)



#### Overall Dimensions (Front View, 2 of 2)




#### Overall Dimensions (Top View)



**NOTE:** Knockout holes are intended for Class 2 wiring only and are 1/2" (13 mm) and 3/4" (20 mm) diameter.

# Setup

# **Supplied Hardware**

The hardware supplied with the BB-V15 is listed in the following table.

# **Assembly**

#### **Required Tools:**

#2 Phillips tip screwdriver

The back box mounting enclosure assembly comes fully assembled except for a grounding screw. To prepare for mounting complete the following procedure.

- 1. Remove knockouts as required.
- 2. Attach the supplied #08-8B self-tapping screw (2007277) to back box mounting enclosure assembly for grounding. Refer to the first illustration on the page 7.

# **Mounting**

#### **Required Tools and Materials:**

- #2 Phillips tip screwdriver or hammer
- Level
- Standard drywall screws or nails (not included)

CAUTION: Allow an air gap of at least 12 inches (305 mm) in the wall cavity above and below the touchpanel for heat dissipation.

**NOTE**: If your installation is not on wooden studs, be sure to consider the needs of your particular situation. For example, screw type may vary for steel studs, etc.

**NOTE**: To maintain optimum structural integrity, Crestron recommends installing header and footer studs around the BB-V15 and the required air gap.


**NOTE**: The BB-V15 requires a 17" (432 mm) wide space between the studs where it is to be placed. The BB-V15 will not fit otherwise.

**NOTE**: The BB-V15 has been optimized for mounting in 5/8" (15 mm) drywall. You may use 1/2" -1" (12.5-25 mm) without issue. Thinner or thicker drywall will cause issues with the installation.

Complete the following procedure (refer to illustrations on the next page) to mount the back box.

1. Frame the opening for the BB-V15. Refer to the image below for visual guidance.


#### Framing the BB-V15



- 2. Position the symmetrical back box against the stud so the extended edge of the mounting plate covers the front edge of the stud. Be sure the side of the back box is also against the side of the stud.
- 3. Use the level and verify the back box is horizontal. Leveling must be done before proceeding.
- 4. Attach the back box to the left and right stud with standard drywall screws or nails (not included). Refer to the illustration on below.
- 5. Feed wires through knockout holes.


**NOTE:** This assembly should use Class 2 wiring only.

**NOTE:** BE SURE THE ASSEMBLY IS LEVEL WHEN MOUNTED.

**NOTE**: Cut the drywall along the inside edge of the front of the back box. The labels on the front of the back box indicate the perimeter of the opening that should be cutout. Refer to the **NOTE** in "Mounting the Back Box" shown on previous page.


**NOTE**: The six tapped holes on the front of the back box must be exposed to accept the touchpanel mounting screws. These holes are found along the top and bottom of the opening made by cutting out the drywall. Refer to the **NOTE** in "Mounted View with Cover Plate" shown above.

# **Touchpanel Installation**

Complete the installation by either installing the touchpanel, leaving the hole open (if permitted by local building codes) or installing the optional cover plate with the included  $\#06-32 \times 1 \ 1/2$ " screws, as shown in the illustration on the previous page.

If the touchpanel is to be installed, refer to the latest revision of the V15-WALL and WMKC-V15 Installation Guide (Doc. 6884) for installation instructions. # **Other Mounting Option Accessories**

If too much of the mounting plate is exposed after the drywall is cut, you may need to patch the area. Crestron provides the following accessories:

- MMK-V15 (Doc. 6885) for larger repairs and to fill in larger irregularities around the opening (requires plastering).
- WMKT-V15 (Doc. 6803) for smaller repairs and to provide a smooth edge at the opening. This option provides a finished appearance and is preferred when wallpaper is hung.

# Merchandise Returns / Repair Service

- No merchandise may be returned for credit, exchange or service without prior authorization
  from CRESTRON. To obtain warranty service for CRESTRON products, contact an
  authorized CRESTRON dealer. Only authorized CRESTRON dealers may contact the factory
  and request an RMA (Return Merchandise Authorization) number. Enclose a note specifying
  the nature of the problem, name and phone number of contact person, RMA number and
  return address.
- 2. Products may be returned for credit, exchange or service with a CRESTRON Return Merchandise Authorization (RMA) number. Authorized returns must be shipped freight prepaid to CRESTRON, 6 Volvo Drive, Rockleigh, N.J. or its authorized subsidiaries, with RMA number clearly marked on the outside of all cartons. Shipments arriving freight collect or without an RMA number shall be subject to refusal. CRESTRON reserves the right in its sole and absolute discretion to charge a 15% restocking fee plus shipping costs on any products returned with an RMA.
- 3. Return freight charges following repair of items under warranty shall be paid by CRESTRON, shipping by standard ground carrier. In the event repairs are found to be non-warranty, return freight costs shall be paid by the purchaser.

# **CRESTRON Limited Warranty**

CRESTRON ELECTRONICS, Inc. warrants its products to be free from manufacturing defects in materials and workmanship under normal use for a period of three (3) years from the date of purchase from CRESTRON, with the following exceptions: disk drives and any other moving or rotating mechanical parts, pan/tilt heads and power supplies are covered for a period of one (1) year; touchscreen display and overlay components are covered for 90 days; batteries and incandescent lamps are not covered.

CRESTRON is not liable for any claim made by a third party or made by the purchaser for a third party.


