Architectural Series Faceplates: C2NI/INETI-FP

Description

Architectural Series Faceplates bring a clean, updated look to the C2NI/INETI international series of the Cameo [™] keypads. They feature a basic faceplate of injection molded plastic in textured white or black, with machined aluminum inlays available in a variety of finishes including stainless steel, bronze, and polished black, brass, or gold. (Refer to the table below.)


Use the following procedure to install the new faceplates. (Refer to the illustration below.)

- With the thumb of either the right or left hand pressing on the middle of the button area for that side, use fingers to pull that side of the faceplate up and away from the keypad.
- Position the new faceplate over the keypad and firmly press the faceplate until it snaps into position.

NOTE: The surface of the faceplate inlay is protected by a thin plastic film, which should be removed following installation.

Return and Warranty Policies

Merchandise Returns / Repair Service

- No merchandise may be returned for credit, exchange or service without prior authorization from CRESTRON. To obtain warranty service for CRESTRON products, contact an authorized CRESTRON dealer. Only authorized CRESTRON dealers may contact the factory and request an RMA (Return Merchandise Authorization) number. Enclose a note specifying the nature of the problem, name and phone number of contact person, RMA number and return address.
- 2. Products may be returned for credit, exchange or service with a CRESTRON Return Merchandise Authorization (RMA) number. Authorized returns must be shipped freight prepaid to CRESTRON, 6 Volvo Drive, Rockleigh, N.J. or its authorized subsidiaries, with RMA number clearly marked on the outside of all cartons. Shipments arriving freight collect or without an RMA number shall be subject to refusal. CRESTRON reserves the right in its sole and absolute discretion to charge a 15% restocking fee plus shipping costs on any products returned with an RMA.
- 3. Return freight charges following repair of items under warranty shall be paid by CRESTRON, shipping by standard ground carrier. In the event repairs are found to be non-warranty, return freight costs shall be paid by the purchaser.

CRESTRON Limited Warranty
